### EUROPEAN INVESTIGATION ORDER

 EIO for the purpose of hearing a suspected or accused person by videoconference

Consent of the suspect/accused

Summoning and providing information about the rights

# RIGHT TO BE PRESENT

Art. 6 ECHR:

Right to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law. Rights of the accused:

- (a) to be informed promptly, in their language and in detail, of the nature and cause of the accusation;
- (b) adequate time and facilities to prepare their defence;
- (c) to defend in person or through legal assistance;
- (d) to examine witnesses;
- (e) to have the free assistance of an interpreter.

Art. 47 – 48 CHARTER OF FUNDAMENTAL RIGHTS OF EU LEGAL GROUNDS Rights to a fair and public hearing; reasonable time; an independent and impartial tribunal; advised, defended and represented; legal aid available to ensure effective access to justice; right of the defence guaranteed.

# RIGHT TO BE PRESENT

- Presence in person
- Effective participation in the trial
- Equality of arms
- Adversarial trial
- Hearing within a reasonable time
- Right to interpretation and translation
- Information of the nature and cause of the accusation
- Defence time and facilities to prepare; legal assistance
- Right to examine witnesses
- Appeal?

#### BASIC ASPECTS

### TRIAL VIA VIDEOCONFERENCE

#### -USE OF EIO:

- guilty plea;
- acknowledgement of the factual basis of the indictment;
- consent to an agreement;
- announcement of the sentence of the issuing court?

#### - AMENDMENTS OF THE EIO DIRECTIVE:

- secrecy of the communication with the lawyer;
- participation in the interrogation of witnesses;
- oral pleading;
- negotiating of an agreement;
- announcement of the sentence and appeal.
